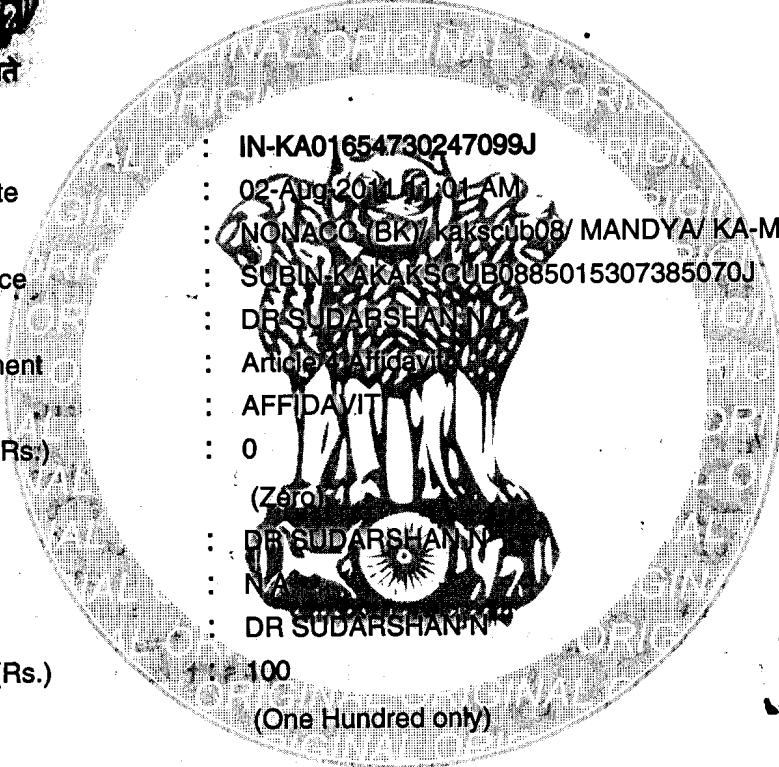

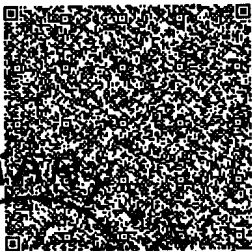

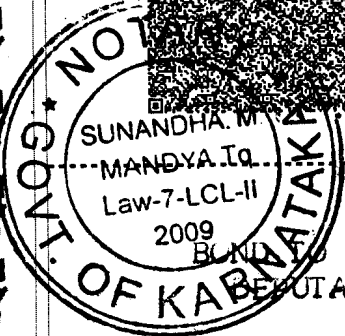

AND TOGETHER with all cost between attorney and client and all charges and expenses that shall or may have been incurred by the Government.

WHEREAS the Obligor is granted Deputation to Higher Studies/ Specialised Training by Government.

AND WHEREAS for the better protection of the Government the Obligor has agreed to execute this Bond with such condition as hereunder written:

AND WHEREAS the aforesaid Sureties have agreed to execute this Bond as Sureties on behalf of the above bounden. NOW THE CONDITION OF THE ABOVE WRITTEN OBLIGATION IS THAT in the event of the Obligor failing to resume duty or resigning from service or otherwise quitting service, without returning to duty after the expiry of termination of the period of the duty, the Obligor and the Sureties shall forthwith pay to the Government or as may be directed by the Government on demand the said sum of Rs.10,00,000/- (Rupees Ten Lakhs only) together with interest thereon from the date of demand at Government rates for the time being in force on Government loans.

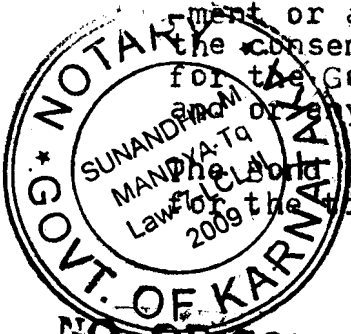
It shall be lawful to the Government to make recovery of the amount (including Pay and Allowances, Stipend, D.A., Tuition Fees etc.) spent on higher studies/specialised training from the salary of the Obligor in case the competent authority comes to the conclusion that he has not shown sufficient progress in the studies or had failed to complete the course in proper time. In case it is not possible to recover from the salary, the Obligor and the Sureties shall be jointly and severally liable for the repayment of full amount of expenditure incurred by the Government.

And upon the Obligor Dr.Sudarshan.N, Siddaiah.N.S., Muni Venkatesh.T the Sureties aforesaid making such payment, the above written obligation shall be void and of no effect, otherwise it shall be and remain in full force and virtue:

Provided always that the liability of the Sureties hereunder shall not be impaired or discharged by reason of time being granted or by any forbearance, act, or omission of the Government or any person, authorised by them (whether with or without the consent or knowledge of the Sureties) nor shall it be necessary for the Government to sue the Obligor before suing the Sureties and any of them for amounts due hereunder.

The Bond shall in all respects be governed by the Laws of India for the time being in force and the rights and liabilities

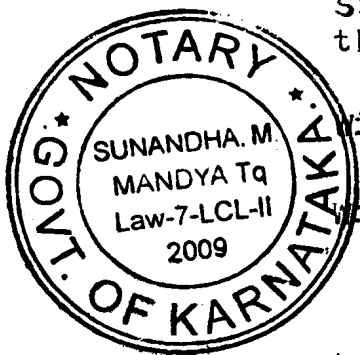
