

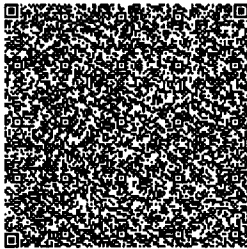



WHEREAS the Obligor is granted Deputation to Higher Studies by Government.,

AND WHEREAS for the better protection of the Government the Obligor has agreed to execute this Bond and with such condition as hereunder written.

AND WHEREAS the aforesaid Sureties have agreed to execute this Bond as sureties on behalf of the above bounden. NOW THE CONDITION OF THE ABOVE WRITTEN OBLIGATION IS THAT in the event of the Obligor failing to resume duty or resigning from service or

otherwise quitting service, without returning to duty after the expiry of termination of the period of the deputation or at any time within a period of three years after his return to duty, the Obligor and the Sureties shall forthwith pay to the Government or as may be directed to the Govt. on demand the said sum of Rs.10,00,000/- (Rs.Ten Lakh only) together with interest thereon from the date of demand at Government rates for the time being in force on Government loans.

It shall be lawful to the Government to make recovery of the amount (including Pay and Allowances, Stipend, D.A. Tuition fees, etc) spent on higher studies from the salary of the obligor in case the competent authority comes to the conclusion that he has not shown sufficient progress in the studies or had failed to complete the course in proper time. In case it is not possible to recover from the salary, the Obligor and the Sureties shall be jointly and severally liable for the repayment of full amount of expenditure incurred by the Government.,

And upon the Obligor Dr.Suresh.C. and Dr.Amardeep.G., / Dr.Yatish, the Sureties aforesaid making such payment, the above written obligation, shall be void and of no

effect, otherwise it shall be and remain in full force and virtue.

Provided always that the liability the Sureties hereunder shall not be impaired or discharged by reason of time being granted or by any forbearance, act, or omission of the Govt. or any person, authorized them (whether with or without the consent or knowledge of the sureties) nor shall it be necessary for the Govt. to sue the Obligor before suing the Sureties and or any of them for amounts due hereunder:

The Bond shall in all respects be governed by the Law of India for the time being in force and the rights and liabilities hereunder shall where necessary be accordingly determined by the appropriate Courts India.,

The Govt. of Karnataka has agreed to bear the Stamp Duty payable on this bond.
